ON OCTOBER 1, 2014, WITH AMENDMENTS, FOR FISCAL YEAR 2015**

The City of Albany in Common Council convened, does hereby ordain and enact:

Section 1. The budget as presented by the Mayor on October 1, 2014, is hereby adopted as and for the Budget of the City of Albany for fiscal year 2015 with the following amendments.
