




Mandatory Multi-Residential & Commercial Recycling Guide

Pursuant to 313-16 of the city code, all commercial, industrial and institutional establishments within the City of Albany shall source-separate and arrange for the collection of designated recyclables as outlined below. Violators of this code may be subject to a fine.
